## Mark Deal and Scholarship Winners Discuss “What it Means to be a Brickie” at the HHSAA Annual Meeting

Hobart Brickie football star and Class of 1975 graduate Mark Deal was the guest speaker at the HHSAA Annual Dinner Meeting on Friday, April 7 at Hobart High School. About 50 people attended the dinner meeting. The singing group Wolfgang entertained the crowd, and we sang "Happy Birthday" to Paul and Ruth Throne, both of whom turn 90 this month.

Scholarship winners for 2017 were announced. They are seniors Sydney Benton and Angelo Guarnero. Each will receive a \$500 scholarship to attend college. Sydney and Angelo read the paragraphs from their scholarship applications on "What it Means to Be a Brickie".

That was also the topic of Mark Deal's address. He recounted what it was like growing up in

Hobart, things like skating on Lake George and eating at Luigi's Pizza, but especially the thrill of the Friday night football games at Brickie Bowl, watching his father, Russ Deal, and his older brother Mike Deal. He named several coaches, players and teachers who were an inspiration to him and his family, including Frank Kurth, Tom Kerr, and Paul Throne. It was an emotional moment for all when he told of the football players carrying Don Howell's casket out of St. Bridget Church and giving Coach Howell one last Brickie salute.

## Nancy Thomason: Traveler, Protector, and Director on the Mary Kay Foundation Board

Nancy Thomason, HHS Class of 1971, is on the Board of Directors of the Mary Kay Foundation, and worked with Mary Kay Ash personally for 21 years. Nancy's story begins on the next page.

*Where do you live now, and what are you doing these days?*

Dallas, TX, has been home since graduating from college. Currently I manage the day to day operations and fundraising activities of The Mary Kay Foundation, a nonprofit organization.

I am on the Board of Directors for The Mary Kay Foundation and just rolled off the Board of Directors for Cancer Support Community North Texas after 8 years. I have stayed quite busy with these two organizations. As the Executive Project Specialist with Mary Kay, I also assist with the preservation and restoration of museum artifacts related to Mary Kay Ash and the company, research historical requests from sales force, staff and general public, including projects related to Mary Kay Ash.

Like most, I enjoy good food and wine. I was one of the founders of a group called Patio Princesses® which was established in 2009 as a women's social organization based in Dallas. This group met monthly at Dallas' finest and choicest restaurants and patio venues, offering culinary explorations and special events to professional women of all ages. With a mailing list of over 300, it was great fun and many lifelong friends were brought together. Due to work and travel, we suspended the organization after six years but I look forward to kicking it off again once I retire...whenever that may be.

I enjoy traveling and never met a trip I didn't like. This year's trips are San Miguel de Allende, Portugal and Cuba. In my free time, I enjoy attending plays, the symphony, jazz concerts, going to museums and getting together with friends and family. I am trying to get back into the swing of golf again after taking some years off the course.

Love getting back to Hobart to visit my brother Don (class of '67), his wife Dixie, other family and friends. You may know my brother by the name of Auto, Ralph or no telling what other name of which I am unaware! I am thrilled my niece, Katie (class of '03), and her family live in Ft. Worth,

Texas, which enables me to see them more frequently.

*Could you trace your career path from Hobart High School to how you first became involved with Mary Kay?*

After graduating from Hobart High, I attended college at Western Kentucky University where my mother also attended college. I studied music, elementary education and outdoor recreation. Later I earned a master's degree in business and human resource management.

When I moved to Dallas after college, my first job was as a crime prevention specialist at Southern Methodist University. From there I was hired as a police officer in Plano, TX.

Mary Kay Cosmetics was looking for a female law enforcement officer to manage the personal protection program for the company and provide day to day personal protection for the company's Chairman of the Board, Mary Kay Ash. I was interviewed for the position and hired immediately.

At Mary Kay Inc. I developed and supervised the executive protection program for the Company, provided personal physical protection for Mary Kay Ash, top executives and family members. I trained and supervised the executive protection staff and managed all aspects of Mary Kay Ash's physical security systems.

Licenses included Personal Protection, Personal Protection Instructor for the State of Texas, Private Investigator, etc.

I had the amazing opportunity to attend the crème de la crème executive protection schools in the country conducted by Secret Service and FBI agents, meeting the protectors of many national and international dignitaries.

*Please tell us about your experience with Mary Kay Ash and the company.*

I feel very fortunate to have had the privilege of providing personal protection for Mary Kay Ash, accompanying her on a daily basis in the U.S. and internationally, working closely with her for 21 years. She was such an inspirational and visionary woman who always kept her priorities in the order of God first, family second and career third. How can one not be inspired by a woman who started a company with a \$5,000 investment that is now worth \$4 billion, influencing so many lives in such a positive way?

My first traveling experiences with Mary Kay were to accompany her on an exhaustive national book tour that lasted months when she was promoting her autobiography. Years later there would be two additional book tours. Traveling in private jets and limousines was a totally new experience for me in addition to seeing and meeting many celebrities in the green rooms and makeup rooms of television studios, and staying in presidential suites at some of the most prestigious hotels in the country. (Hey, I grew up in West Hobart, 2 blocks from Gary...needless to say, I was wowed!)

My position required extensive travel on protective assignments in the United States, Canada, Mexico, Europe, the Far East and the Caribbean.

From Mary Kay's stroke in 1996 to her death in 2001, I was in charge of the staff at Mary Kay's house, managing Mary Kay's care and her personal affairs.

*What is the Mary Kay Foundation, and what is your involvement with it?*

The Mary Kay Foundation is a nonprofit organization which is committed to eliminating cancers affecting women by supporting top medical scientists who are searching for a cure for breast, uterine, cervical and ovarian cancers. The Foundation is also committed to ending the epidemic of violence against women by providing grants to women's domestic violence shelters and supporting community outreach programs. We are very proud that, to date, the Foundation has provided more than \$69 million to these two missions.

Today I am responsible for management of the Foundation, fundraising activities, financials and administration of the Foundation. I assist our team with planning, coordinating and executing company fundraising projects at special events, the Foundation's MK5K, the Mary Kay golf classic, etc.

I coordinate special fundraising projects initiated by independent sales force members, helping them decide the best type of fundraiser for that person, giving guidance on how to make the event successful, and using resources available to help promote the event. Follow up is required to ensure funds are received, thank-yous sent and recognition given for their events.

I represent Mary Kay Inc. and the Foundation at sales force events both in the U.S. and internationally, at community luncheons, and act as a liaison between sales force, the Foundation, and outside organizations. I am also responsible for correspondence from the Foundation, assist with research and proof Company approvals on projects specifically related to the Foundation.

*Were there any teachers, classes or experiences in the Hobart school system that helped shape your career?*

My 5<sup>th</sup> grade teacher at Ridge View, Marvin Thomae, influenced my life. Mr. Thomae was a brilliant elementary teacher, inspired a lifelong curiosity to learn more, achieve more and influenced my love for reading. He had recently graduated from college and this may have been his first teaching assignment. We never forget where we were when we learned President John F. Kennedy was assassinated. Many times I have thought back to how this young teacher tenderly handled our 5<sup>th</sup> grade class with all of our uncertainties and questions during those momentous times. He was stellar!

Our beloved band director, Ray Grivetti had a major influence on my life. Through his leadership and example of persistence toward excellence, I attended college on a music scholarship, playing the oboe. The friendships, band camp, solo and ensemble competitions, the jazz band, the trip to Europe playing in the jazz band, the countless hours of practicing at home, in the band room, hours practicing to march in parades, practicing formations on the football field taught me the value of team work, preparation, time management, having a sense of humor and self-esteem for a job well done.

- Honesty is the cornerstone of all success.

# Hobart High School, 100 Years Ago

In April 1917, the United States declared war on Germany, and entered World War I, a conflict that had been raging in Europe since August of 1914. One of Hobart's most recognized landmarks is the Doughboy Monument, at 7<sup>th</sup> and Main Streets, just south of the tracks, which commemorates American soldiers who fought in World War I.

At Hobart High School, seniors were getting ready to graduate when they heard the news that the country was at war. In the 1917 yearbook, *The Aurora*, Music and English teacher Helen Kolb wrote a poem titled "To the Seniors", which is reprinted here.
